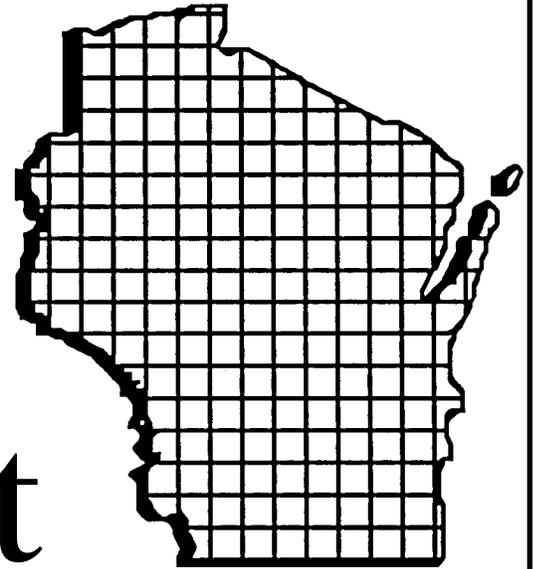

*A Survey of Wisconsin Public Opinion on
the Presidential Election and Indian
Casino Gambling*

SUMMARY

A study of 587 Wisconsin residents who expect to vote was conducted by telephone October 18 through October 21, 2000. A survey of 587 randomly selected residents has a margin of error of plus or minus 4 percent for percentages of the whole sample. For a percentage near 50 percent, for example, this means that repeated samples would produce results between 46 percent and 54 percent 95 times out of 100.

An additional study of 660 Wisconsin residents was conducted by telephone October 18 through October 21, 2000. A survey of 660 randomly selected residents has a margin of error of plus or minus 4 percent for percentages of the whole sample. For a percentage near 50 percent, for example, this means that repeated samples would produce results between 46 percent and 54 percent 95 times out of 100. All interviewing for both studies was conducted from the telephone centers of Harris Interactive.

Harris Interactive, Inc. is a firm specializing in market research and public opinion polling, headquartered in Rochester, New York. Dr. Gordon S. Black is the author of the survey. Dr. Black has his Doctorate in Political Science from Stanford University and is a widely known authority on public opinion, voting behavior and opinion research methods.

These study results were released to the news media in late October 2000.

GOVERNOR GEORGE W. BUSH MAINTAINS LEAD OVER VICE PRESIDENT GORE IN RACE FOR PRESIDENT

-- Spread between Bush and Gore remains virtually unchanged since June --

Governor George W. Bush holds a solid 49% to 40% lead over Vice President Al Gore in a four-person race with Ralph Nader receiving 5% and Pat Buchanan receiving 1% with the balance (5%) remaining undecided among Wisconsin residents who expect to vote in the 2000 general election. This is the key finding about politics from the most recent survey of Wisconsin residents conducted by the Wisconsin Policy Research Institute, Inc., and Harris Interactive, Inc. between October 18 and October 21, 2000.

The poll results clearly indicate that Bush is maintaining his lead over Gore as the race heads into the last few weeks before the November general election. As the table below shows, the spread between the top two nominees has remained remarkably stable, varying by only one percentage point, compared to results from the June poll. What has changed is the support received by third party candidates; Nader has dropped four percentage points (from 9% to 5%) and Buchanan has dropped two percentage points (from 3% to 1%).

The following are some key additional findings about the four-man presidential race for key voter groups.

- **Gender:** The gender gap between Bush and Gore is still clearly evident with a majority of men (55%) supporting Texas Governor George W. Bush and a plurality of women (46%) supporting Vice President Al Gore. Men and women support the third party candidates in about equal proportions.

- **Age:** Bush leads in the 25 to 54 age group, while Gore leads among those 55 and older and among those 18 to 24. Results by age group are as follows:

- **Geography:** At this point in the campaign, Bush continues to hold strong leads in traditionally Republican parts of the state and does better than most Republicans in Democratic areas.

In the city of Milwaukee, traditionally a Democratic stronghold, Bush garners a surprisingly high 38% of the vote to 51% for Gore, 2% for Ralph Nader, and 2% for Pat Buchanan. In the Madison area, Gore leads Bush 49% to 37% with Ralph Nader receiving 12%.

In the Milwaukee suburbs, Bush has a significant lead over Gore 68% to 25%. In the Republican stronghold of Waukesha county, Bush earns fully 72% of the vote to Gore's 23%.

The Green Bay area represents Bush's slimmest lead over Gore, 49% to 38%. Here, the 6% in Nader's column and the 5% who are undecided could have a potentially greater effect than anywhere else in the state. Buchanan's support is greatest in the La Crosse/Eau Claire area with 3%, however Bush garners the majority with 52% compared to Gore at 39% and Nader with 7%.

- **Political Party:** Although Nader's impact on the campaign has decreased since June, with 6% of his support coming from Democrats, he still could pose a problem for Al Gore. Buchanan on the other hand, shows no support from Republicans, instead drawing all his support from Independents. Results by political party are shown below.

- **Ideology:** Nader also impacts Gore among liberals. Overall, 59% of Liberals expect to vote for Gore, 15% for Nader, 16% for Bush, and 4% for Buchanan. Among conservatives, 72% expect to vote for Bush, 23% for Gore, 1% for Buchanan, and 2% for Nader. Among middle-of-the-road voters, Bush would earn 47%, Gore 42%, Nader 4%, and Buchanan 1%.

- **Religion:** A majority of Protestants (57%) support Bush compared to Gore at 32%, and Nader at 5%. Although Gore finds more support among Catholics (43%) compared to Protestants, a plurality of Catholics support Bush (49%) while 3% support Nader. While Buchanan receives 2% of the Protestant vote he doesn't register among Catholics.
- **Race:** Gore finds strong support from African-Americans, earning 81% of their vote compared to only 10% for Bush. Among Whites, Bush leads with 51% to 37% for Gore, 6% for Nader, and 1% for Buchanan.
- **Marital Status:** Among married voters, Bush holds a 55% to 34% advantage over Gore with Nader at 5%. Singles give Gore a 49% to 38% lead over Bush, with Nader at 8% and Buchanan at 2%. Those that are Divorced or Widowed are also in Gore's corner, 48% to 38%, with 6% for Nader and 3% for Buchanan.

BUSH'S 'POSITIVE' RATINGS STILL HIGHER THAN GORE'S

-- Both Third Party Candidates Show Declines in Favorability --

One reason that George W. Bush leads is that people simply seem to like him more. At least that is what the results shown on the following page would suggest. Although Gore has closed the gap with Bush somewhat since June, overall, 52% have a favorable opinion of Bush compared to only 45% for the Vice President.

With fewer people feeling 'neutral' about the major party candidates, opinions, both 'positive' and 'negative' of the Vice President and the Governor have increased slightly since June: Bush's 'positive' rating has increased from 51% favorable to 52% favorable while Gore's 'positive' rating has increased by a wider margin from 41% to 45%. Interestingly, both candidates have seen their unfavorable rating increase by 5%, Bush's increased from 36% to 41% and Gore's increased from 43% to 48%.

It is interesting to note that all the movement in the ratings for both Nader and Buchanan has been in their 'negative' ratings. Nader's unfavorable rating has increased from 25% to 36% while Buchanan's unfavorable rating increased from 50% to 53%. While just over a third (35%) have a 'positive' view of Nader, only 17% report a 'positive' view of Buchanan.

A perennial favorite, Senator Kohl's favorability rating continues to increase from 64% in June to 69% in October, with 17% unfavorable, and 13% who are neutral or do not recognize his name. His opponent, John Gillespie, with 22% favorable and 13% unfavorable, seems to be suffering from a lack of name recognition with almost two-thirds (64%) reporting that they are neutral or do not recognize his name.

SENATOR KOHL POISED FOR RE-ELECTION

-- Kohl's Receives Substantial Support Across the Board --

More than two-thirds (67%) of Wisconsin Residents who expect to vote support the re-election of Herb Kohl compared to 24% who plan to vote for his opponent John Gillespie. As a popular Democratic Senator, Kohl receives the support of almost every group across the board, ranging from 91% of Democrats and 67% of Independents to 43% of Republicans. Detailed findings are shown in the tables below.

-- Economy Ranks as Second Most Important Consideration --

When Wisconsin residents who expect to vote were asked what their most important consideration was when selecting a president from a list of five choices, "electing someone who cares about the same issues as you do" was rated as the most important consideration by 27%, 23% rated "keeping the economy strong and growing", 19% selected "providing strong leadership for the nation", 17% chose "the character of the candidate", and 9% reported "bringing change and reform to Washington" as their most important consideration.


Among Democrats, "keeping the economy strong and growing" ranked as the most important consideration (30%), while conservatives rated "the character of the candidate" (27%) as their most important consideration. Detailed findings are reported in the tables below.


Wisconsin Residents' Preferences in the 2000 Presidential Race





WISCONSIN RESIDENTS CONTINUE TO SUPPORT ON-RESERVATION CASINO GAMBLING

~ Residents Voice Strong Opposition to Off-Reservation Operations ~


More than six out of ten (62%) Wisconsin residents continue to favor the operation of casino gambling by Wisconsin Indian tribes on their reservations, 27% oppose, and 10% are not sure. This is one of the key findings from the most recent survey of 660 Wisconsin residents conducted by the Wisconsin Policy Research Institute, Inc. and Harris Interactive between October 18 and October 21, 2000.

These results show only a slight change since 1997, the last time this question was asked, when 64% of residents were in favor, 31% were opposed, and 5% were not sure.



Support is strongest among residents aged 18 to 34 with 67% in favor of on-site gambling operations, while residents 55 and older show the least amount of support (54%). Residents 35 to 54 fill the middle ground with 63% in favor of on-site gambling operations.



When residents were asked whether they favor or oppose the expansion of Indian casinos to off-reservation locations, almost two-thirds (65%) of state residents reported that they are in opposition, 27% are in favor, and 8% are not sure.



Across regions of the state, opposition to off-reservation casinos is strongest in the Madison area where 75% of residents are opposed and 21% are in favor. Support for off-reservation casinos is somewhat stronger in the City of Milwaukee where just over a third (34%) of residents favor the expansion while 56% are opposed (see Table 2).
